

Residency recruitment for the European College "Animal Welfare, Ethics and Regulations"

VetAgro Sup Veterinary Campus

### Background

VetAgro Sup and Boehringer Ingelheim are partnering to propose a new Residency position in order to contribute to better **animal care and improvement of animal welfare, in particular in the context of use for scientific purposes.**

Through this collaboration, the Resident will benefit from two recognized structures to support his/her training and to fulfill the obligations of the Residency (i) with a strong professionalizing approach, since half of the time will be spent on a site from Boehringer Ingelheim, and (ii) benefiting during the first year of residency of the mentoring of the current Resident of the animal welfare team.

### Objectives and missions of the residency programme

The objective of the candidate's specialization program is to develop, over a three-year period, an expertise in animal welfare, ethics and regulation, and specifically:

- Clinical expertise in the welfare of animals from different species.
- A 3-year Research activity in the field of animal welfare
- Training, expertise, and exchanges with stakeholders and Key Opinion Leaders in animal welfare, ethics and related regulations.

To this end, the resident will have access to the clinics of the VetAgro Sup Veterinary school and will benefit from the partnerships and network developed by the animal welfare team (veterinarians, breeders, research institutes, ...), as well as the clinical cases of animals hosted on the Boehringer Ingelheim site of Saint Vulbas and the site's expertise Research and Development in animal health.

After the three years of residency, the resident will be able to apply for the examination for the title of European specialist of the College of Animal Welfare, Ethics and Regulation ([http://www.ecawbm.com/wp-content/uploads/2019/01/Examination-Brochure-26\\_09\\_18.pdf](http://www.ecawbm.com/wp-content/uploads/2019/01/Examination-Brochure-26_09_18.pdf)).

The resident will be supervised by Luc Mounier (professor of Animal Welfare, team coordinator and Graduate of the European College) and Marianne Curet (DVM, Site Head of Boehringer Ingelheim Saint Vulbas R&D site), and integrated into each of the structures within the teams specialized in animal welfare. The working program will be reassessed jointly by the animal welfare team and Boehringer Ingelheim.

### Profile

The specialization program is open to veterinarians qualified for at least 1 year and with a year of clinical practice or related to animal welfare issues.

National trips to be planned and international trips possible over the 3-year period.

Driving license valid in France and personal vehicle are needed to be present at both sites.

Competencies required: Analytical and organizational capacities; Scientific curiosity; Willingness to be a change agent; Interpersonal skills, with a true team spirit. Ability to communicate in terms that can be understood by a variety of stakeholders. Good command of English and French (oral/written)

### Recruitment and Information

The program is scheduled to open in the first quarter of 2022.
